

**AFFIDAVIT FOR PERMIT APPROVAL TO CONSTRUCT

intend to construct a nonresidential dwelling and understand and agree to the following conditions regarding the installation and maintenance of an onsite sanitary sewage storage facility in accordance with the Monroe County Sanitary Code at the above-described property

1. *The owner is fully aware that the soil conditions on said parcel are not conducive for the proper operation of a conventional onsite wastewater disposal system and will utilize an onsite sanitary sewage storage facility for wastewater disposal.*
2. *The owner agrees that the wastewater disposal system will be operated and maintained in a manner so as not to create a nuisance or health hazard and stay in compliance with the Monroe County Sanitary Code.*
3. *The owner agrees the nonresidential dwelling will be connected to an approved public wastewater collection system when available.*
4. *The restrictions and conditions of this permit shall apply to any person or legal entity which now or shall hereafter own or operate the facility for which this permit is issued. In the event of any change in ownership or principal operator status of this facility, the permittee shall notify the new owner, in writing, of the existence of this permit and forward a copy of such notification to the Director of Environmental Health of the Monroe County Health Department.*
5. *Sanitary sewage resulting from the operation of the non-residential facility as described in the application to be less than 100 gallons per day shall be stored onsite, transported and ultimately disposed of in such a manner and by means that the activity does not injuriously affect public health, safety or welfare or injuriously affect commercial, industrial, domestic, agricultural, recreational or other uses of the ground waters or surface waters of the State.*
6. *There shall be no by-passing or overflowing of the wastewater holding systems nor disposal of wastewater at any other locations other than those approved nor under any conditions which would allow the entry of untreated or inadequately treated wastewaters to the ground waters or surface waters of the State. Practices that are potentially injurious to public health, safety, or welfare, are not authorized. Whenever the permittee is unable to comply with any of the conditions of this permit due to a breakdown, the permittee shall halt, reduce, or otherwise control the operation of the \_\_\_\_\_ non-residential facility to such extent that the provisions of this affidavit are met.*
7. *On forms provided by the Environmental Health Division of the Monroe County Health Department, the permittee shall annually report the volume of wastewater transported and disposed of from each disposal site.*
8. *Low water use fixtures shall be used at this facility.*
9. *The onsite sanitary sewage storage facility shall be equipped with a high liquid level alarm, which operates in both the visual and audible modes.*
10. *The owner agrees to advise all prospective buyers of this Affidavit by including it as part of any Sales Agreement for the above-described property.*

The owner understands that failure to comply with the above agreement may result in the condemnation of the dwelling as unfit for human habitation and legal action as provided for in the Monroe County Environmental Health Sanitary Code.

This affidavit becomes void upon connection to an approved public wastewater disposal system or subsurface onsite sewage disposal system.
